SAFETY INSTRUCTIONS FOR INKJET PRINTERS

This document has been prepared based on the requirements of Regulation (EU) 2023/988 on general product safety (GPSR). The purpose of this instruction is to ensure the health protection and safety of inkjet printer users by identifying possible hazards and providing clear guidelines to prevent their occurrence.

1. General hazards and precautions

1.1 Risk of electric shock:

- Connect the printer only to a grounded outlet.
- Do not use the device if the power cable is damaged.
- Do not touch the plug or cables with wet hands.
- Do not open the printer casing risk of contact with live parts.

1.2 Risk of ink contamination:

- Do not touch the printhead or ink cartridges unless necessary.
- If ink contacts the skin, wash it off with water and soap.
- Protect your eyes from ink splashes when replacing cartridges.

1.3 Mechanical risk:

- Do not insert hands inside the printer during operation.
- Avoid using force when inserting paper or ink cartridges.

1.4 Risk of inhaling fumes:

• Use the printer in a well-ventilated area.

• Do not lean directly over the open ink compartment during printing.

2. Specific hazards and ways to minimize them

2.1 Moisture and water:

- Do not use the printer in high humidity rooms (bathrooms, kitchens).
- If the printer is flooded, immediately disconnect it from power and contact service.

2.2 High ambient temperature:

- Do not use the printer at temperatures above 35–40°C (95–104°F).
- Protect it from direct sunlight.

2.3 Non-original inks:

- Use only original or manufacturer-approved ink cartridges.
- Avoid refilling cartridges yourself this may cause ink leakage and damage the device.

2.4 Use by unauthorized persons:

- The printer should only be operated by persons familiar with the instructions.
- Do not allow children to use the device unsupervised.

3. Maintenance and cleaning

3.1 Preparation for cleaning:

- Disconnect the printer from power before cleaning.
- Ensure all mechanical parts have stopped moving.

3.2 External cleaning:

- Clean the casing with a dry or slightly damp cloth.
- Do not use aggressive detergents or solvents.

3.3 Internal cleaning:

- Follow the manufacturer's instructions for cleaning printheads.
- Do not use compressed air it may spread ink inside the printer.

3.4 Ink cartridge replacement:

- Replace cartridges only according to the manufacturer's recommendations.
- Dispose of used cartridges according to chemical waste regulations.

4. Additional recommendations

4.1 Child safety:

- Keep the printer and ink out of reach of children.
- Do not allow children to use the device without supervision.

4.2 Printer installation:

- Place the printer on a stable, level surface.
- Ensure good air circulation do not block ventilation openings.

4.3 Following instructions:

- Read the user manual before use.
- Make sure the device has CE marking and other required safety certifications.

4.4 Disposal:

- Do not dispose of used ink and cartridges in regular trash.
- Follow local regulations for electronic waste and chemicals disposal.
